As per SRO-1413 (I)/2025 dated 1st August 2025, all Companies, AOPs and Individuals registered under Sales Tax Act 1990 are required to integrate their hardware and software with FBR for issuance of e-Invoices bearing Unique Invoice Number issued by FBR, associated QR Code and Digital Invoicing Logo.

The compliance of SRO-1413 requires extensive work on the existing invoicing software, registration with FBR, testing of integration through Sandbox and issuance of e-invoices. Therefore registered persons should act very smartly for ensuring timely compliance in order to avoid legal implications, departmental notices and penal action.

In order to facilitate the Registered Persons for complying with SRO-1413; we have launched Digital-Invoicing (DI) which is Cloud Based, Robust, Secure, Reliable, FBR Compatible & Economical ERP Solution. 

As per SRO-1413 (I)/2025 dated 1st August 2025, all Companies, AOPs and Individuals registered under Sales Tax Act 1990 are required to integrate their hardware and software with FBR for issuance of **e-Invoices** bearing **Unique Invoice Number issued by FBR, associated QR Code and Digital Invoicing Logo** by various type of registered persons latest up to following dates:

1) 01-09-2025	Public Companies and Other than Public Companies who have declared turnover
	of more than one (1) billion rupee in last 12-Sales Tax Returns and Importers
2) 01-10-2025	All Companies, AOPs and Individuals who have declared turnover of more than
	100 million rupee in last 12-Sales Tax Returns
3) 01-11-2025	All Companies who have declared turnover not exceeding 100 million rupee in last
	12-Sales Tax Returns.
4) 01-12-2025	All Registered Persons other than those listed at SR-1, 2 & 3 above which include
	all Individual and AOPs like wholesalers, distributors, contractors, general order
	suppliers, service providers, etc.
